1. Call to Order & Introductions

H. Letter of Support: Regional Mobility Grant – Twin Transit Connector Services and Hydrogen Fueled Bus Acquisition


Bill Fashing presented a letter of support written to advocate for Twin Transit's Connector Services and a hydrogen fueled bus acquisition request. No discussion.

5. Other Business


