B. Resolution 24-01: Safety Performance Measures

Robert Stevens provided a brief overview of the 2024 Safety Performance Targets needed to meet federal performance-based planning and programming requirements related to safety.

Motion: Adam Smee moved to adopt Resolution 24-01: Metropolitan Planning Organization's 2024 Safety Performance Targets as presented. Motion was seconded and approved.

C. Resolution 24-02: Surface Transportation Block Grant and Carbon Reduction Program Funding

Robert Stevens requested consideration of Resolution No. 24-02, to select projects to receive Surface Transportation Block Grant (STBG) and/or Carbon Reduction Program (CRP) funding. The total estimated funds available are \$3,389,182 for STBG and \$1,460,807 for CRP.

Project funding was presented as follows: City of Kelso - Talley Way Corridor, planning and design, \$480,000 STBG; Cowlitz County - Coal Creek Road Improvement Project, \$623,398 STBG and \$629,146 CRP; City of Woodland - Gun Club Road sidewalk, bike lane, and the Americans with Disabilities Act (ADA) project, \$461,317 STBG and \$155,075 CRP; City of Castle Rock - Huntington Avenue South Roundabout and pedestrian improvements, \$1,258,600 STBG; CWCOG - Six Rivers Regional Trail Bridge Study, \$110,000 STBG; CWCOG - Cowlitz County and Rainier, Oregon, Rural Transit Feasibility Study, \$130,000 STBG; City of Kalama - Kalama Internal Transit Feasibility, \$100,000 STBG.

Motion: Jennifer Wray-Keene moved to adopt Resolution 24-02: Surface Transportation Block Grant and Carbon Reduction Program Funding. Motion was seconded and approved.

D. <u>Travel Authorization: Target Zero / Lifesavers Conference, Denver, CO</u>

Bill Fashing requested approval for Rachelle Nugent to attend the Target Zero / Lifesavers Conference in Denver, Colorado. Estimated expenses are \$2,500. Travel costs and registration fees will be paid by the Washington Traffic Safety Commission (WTSC) and the Target Zero Program.

Motion: Bill Hallanger moved to approve the travel authorization as presented. Motion was seconded and approved.

5. Information Items

A. Letter of Support: Wahkiakum County - Entrepreneurial Eco System Grant

Letters of Support are authored and submitted in support of area projects prior to board review if the projects are listed in or fall under strategic policy within one of the various transportation or economic development plans or programs previously reviewed and approved by the Board. All projects listed qualify as such.

B. Mobility Management Program Update

Lauren Read presented an update on the Mobility Management Program and a year-end recap of goals and projects. The 2023 program goals were: to increase outreach; implement a quarterly newsletter; provide additional training opportunities; create educational materials; and increase coordination. The 2023 Notable Projects were, a youth activity book, flag stop handouts and slap bracelets; the Trip Assistant website; new marketing materials for youth, employees and tourism purposes; RiverCities Transit – How to Ride videos; and a Youth on the Go survey.

6. Executive Director's Report

Local school districts have levies coming up for election. School representatives were asked to provide information on their local levy elections. Patti Bowen, Longview School District; Ryan Greene, Castle Rock School District; Scott Westlund, Kelso School District; and Michael Green, Woodland School District, provided updates for their districts. More information is available on the districts' websites.

Bill Fashing shared the Cowlitz-Wahkiakum Council of Government's (CWCOG's) goals for 2024 which included capitalizing and promoting safety throughout the region. The CWCOG staff are currently working on a Comprehensive Safety Plan for Cowlitz County and Rainier, Oregon, with a grant from the Federal Highway Administration (FHWA).

The Safe Streets for All (SS4A) program encouraged the CWCOG to apply for funding to support projects within the region. Funding is available for Transportation Demonstration Projects. A match is required.

Staff are developing three Economic Development Symposiums in 2024. The by-invite-only symposiums will cover entrepreneurial eco systems, childcare/quality of place, and business development/attraction with a strong port influence. Notify the CWCOG if you or someone else you know is interested.

7. Executive Committee Report

A. Executive Committee Regular Meeting Minutes November 30, 2023

Executive Committee meeting minutes for November were presented as part of the agenda packet for the Board to review. No action required.

8. Other Business

Dennis Webber shared information on two items. The first being that the Washington Department of Transportation (WSDOT), announced that access to the Johnson Ridge Road will not begin until 2026. The second being that Cowlitz County qualifies for credit on the state sales tax collection of .09%. With the tax credit funding and additional excess funding for Cowlitz County, \$3.2 million is currently available to award for infrastructure projects designed to boost economy and job creation. A Request for Proposal (RFP) will be published towards the end of March.

Bill Fashing noted that Wahkiakum County has similar revenue built up to support projects within that area.

The next Board of Directors meeting will be at the Cowlitz County Event Center, February 22nd.

Troy Stariha reminded the board to complete and return the CWCOG Board Representatives request forms sent out in December.
